4. Real Estate Tax Appeal Order and Settlement - 7251 Beech Road

On a motion by Supervisor Manuele, seconded by Supervisor Nester (Vote 5-0) the Board of Supervisors authorized the Order and Settlement Stipulation between 7251 Beech Road v. MONTCO Board of Assessment

Appeals resulting in the increase assessment for 2022-2023 requiring a payment of \$373.40 to the Township for real estate taxes.

5. Real Estate Tax Appeal Order and Settlement - 551 East 10th Avenue

On a motion by Supervisor Toll, seconded by Supervisor Manuele (Vote 5-0) the Board of Supervisors authorized the Order and Settlement Stipulation between 551 East 10th Avenue v. MONTCO Board of Assessment Appeals resulting in the increase assessment for 2023 requiring a payment of \$435.37 to the Township for real estate taxes.

6. Real Estate Tax Appeal Order and Settlement - 500,506,510,512 Pennsylvania Avenue/BMW

On a motion by Supervisor Manuele, seconded by Supervisor Nester (Vote 5-0) the Board of Supervisors authorized the Order and Settlement Stipulation between 500, 506, 510, and 512 Pennsylvania Avenue v. MONTCO Board of Assessment Appeals resulting in the increase assessment for 2022-2023 requiring a total payment of \$1,356.56 to the Township for real estate taxes.

4. May 2023 Expenditures and Payroll and Pension Plan Paid Costs

On a motion by Supervisor Toll, seconded by Supervisor Manuele (Vote 5-0) the Board of Supervisors approved expenditures totaling \$935,920.32; and payroll totaling \$603,742.92; and pension paid costs totaling \$4,111.29 for May 2023.
